

**1. PARTICULARS OF THE EXECUTIVE COMMITTEE TO BE ELECTED FOR A TERM OF 4 YEARS (i.e.) 2021-25 FROM THE DATE OF ELECTION:**

**2. MANNER OF ELECTION:**

- The Elections will be held as per the provisions of the Memorandum of Association of UOA and the guidelines of the National Sports Development Code 2011.
- All central/state government employees along with their nomination form will also file a disclosure/ undertaking form stating that they are in the service of the central or their respective state government. Furthermore, employee Id issued by the central/state government and a No Objection Certificate (NOC) from their respective employer is also to be submitted by such individuals. Only if such candidates submit the aforementioned documents along with their nomination form their nominations will be deemed valid to be considered.
- The election shall be held by way of a secret ballot only, unless elected unopposed.
- Every member of the State Sports Association / District Olympic Association who is in good standing in accordance with the Memorandum of Association and Byelaws of Uttaranchal Olympic Association, enlisted in the Electoral College to participate in the elections. State Sports Association - 02 (Two); District Olympic Association - 01 (One) representative each shall be entitled.



- Representatives should carry necessary identity card such as Aadhar card indicating the belongingness from the concerned State. Based on the same, Entry-card for UOA-Elections will be issued.
- Duly filled-in Nomination forms in Form No:2 to be physically delivered to the Returning Officer, as detailed under the following Schedule.
- Each candidate shall be entitled to be nominated by not more than 2 nomination papers.
- No person shall be eligible to nominate more than one candidate for the same post, either as Proposer or Secunder.

### 3. Grievances:

Any member of the Electoral College constituted in accordance with the procedure under the National Sports Development Code, 2011, GOI and the Constitution of the UOA, having any grievance on any aspect of the electoral process, may approach the Returning Officer with the same.

#### Important Note:

- (A) SOP of Uttaranchal Olympic Association for conduction of Annual General Body Meeting (AGM) at Rudrapur, Uttarakhand on 17<sup>th</sup> October 2021 (Sunday)

#### GENERAL GUIDELINES

- All are required to undergo the RT-PCR test 3 days (72 hours) prior to their date of event and to bring the report along to be submitted on arrival.
  - All participants have to travel as per the Covid - 19 safety guidelines for traveling, to avoid any chance of contamination or exposure to the virus.
  - Carry your Own Face Mask / Face Shield / Hand Sanitizer / other substance needed for event (meeting.)
- (B) In an event wherein due to any unforeseen circumstance including but not limited to the ongoing COVID pandemic situation, the permission of ADM could not be obtained, the Election Officer shall have the sole discretion to decide the schedule (venue & date) of the election upon the proposal by the President and/ or Secretary-General of the Uttaranchal Olympic Association.
